


Comments: Second-tier coins were violently erratic in July. Since our longs/shorts were actively involved with these coins, we suffered accordingly. The losses in both funds derived from long/short trading, with no profits coming from arbs. We will trade long/short using the 20 most liquid coins from now on. Diversifying the long/short trading to include noisy second-tier coins is not a good strategy.
